Who Are We and What Do We Do?

Education foundations nationwide were created in the late 1970's as public school budgets across the country were significantly reduced. To offset the serious financial crisis in our schools, and to bridge the financial gap between what was needed for our students and state and federal funding, the Holdrege Public Schools Foundation was formed in 1988 with a \$30,000 grant from the Phelps County Community Foundation for the purpose of establishing an endowment. For more than twenty years our community has responded to the district's needs with tremendous support, recognizing that in today's world, private funding is crucial for public education. Our Foundation Committee is comprised of three school board members, two staff members, and four community members who meet monthly and work on various projects throughout the year.

Results Matter

Results Matter in Nebraska is a child, program, and family outcomes measurement system designed and implemented to improve programs and supports for all children birth to age five served by school districts. The Nebraska Department of Education requires school districts to participate in the Teaching Strategies GOLD assessment system.

Child observation and data collection is an ongoing process throughout the year for all children to collect data for the assessment.

Capture the Moment

The iPad Mini may be small, but it is making a big impact in the HPS Early Childhood Education department. Teacher grant recipient Casey Klein, early childhood and special education teacher, and the other early childhood staff members utilize the Teaching Strategies GOLD assessment system to document each child's progress in 23 objectives covering skills in social-emotional, physical, language, cognitive, literacy, mathematics, and English language acquisition. Teaching Strategies GOLD has developed an application through Apple to assist teachers with documentation. The "app" allows teachers to record ongoing assessments using video, audio, picture, and written form for students in all developmental and academic areas.

Casey's grant provided for three iPad Minis, as well as additional apps that include Bitsboard (recognition of letter, number, emotions), Autism iHelp, Articulation Station, Nursery Rhymes for Kids, Touch & Learn, Count & Learn Money, Jungle Time, and more.

Casey said that the app has allowed us to "Capture the Moment" without taking time away from student learning and parent coaching. The app scores data and uploads it right to the NDE website, a real time-saver! We are able to use the iPad as a "mirror" to help students recognize themselves and point to facial features. The students have enjoyed learning how to use the math and reading apps.

Shana Nitchie, speech pathologist, states that the mini iPads have been very useful in targeting sounds at the word, sentence, and story levels. The iPad also has the capability of recording the student's speech, so they can receive auditory feedback of how they are articulating each sound.

Preschool teacher Betty Amen noted that information can be documented more easily with a video clip or photo than with an observation note. We upload the video and image files and add a note about the context in which the information was collected.

We also take photos of special visitors who come to the classroom, such as the librarian or fire fighters. We can then show them to the students to, once again, help facilitate language.



CADD Students Learn in 3D

Thanks to HPS Foundation grant funds and a generous donation from Allmand Brothers, Inc. of Holdrege, a MakerBot Replicator 2 Desktop 3D Printer has been purchased for teacher Terry Shield's students in the Computer-Aided-Drafting and Design (CADD) class.

Projects created with the 3D printer provide students with valuable insight into the automated manufacturing process. These processes are common to the manufacturing industry which will hire many of our graduating students. It will also provide the students valuable feedback in the design process.

New Arc Welder Keeps Ag Students on Forefront of Real-World Industry Skills

Funds from teacher grant recipient Jeff Moore's HPS Foundation Grant were used in conjunction with donations from the Holdrege FFA Alumni Group to purchase a new Millermatic 252 Wire Feed Welder. The new machine was researched and purchased through Matheson Tri -Gas and put into operation in August with the Introduction to Power

class. The machine will get more use during the school year, with other sections of the Introduction to Power and Metal Fabrication classes utilizing it extensively. The implementation of this grant has helped update the equipment for the high school Ag Shop with a newer model that is used in industry. The MIG welder that the Ag Lab had up to this point was a 2001 model, with another model that dates back to the 1980's. Students have quickly adapted to using the Millermatic and have developed some new techniques.

The students enjoy the digital read -outs, and teacher grant recipient Jeff Moore definitely enjoys knowing that the machine is reliable and consistent with industry and output.


3D Printer (continued)

Mr. Shield stated that previously, one of the challenges he had as an instructor, was to inspire students to design models and study engineering when they never actually see, hold, touch, or feel their designs as a final physical product. To many students, the models they design on the computer screen are often perceived as unobtainable "fantasy" objects. The 3D printer takes models the students design with computer-aided drafting software and creates plastic versions. HPS has now been able to join the ranks of other schools that offer students the opportunity to learn this technology.

Matt Allmand, President of Allmand Brothers, Inc. and Chairman of the HPS Foundation Committee commented, "The community is one of our five stakeholder groups and this was a great opportunity to serve the community and help support students learning about an important emerging technology."


Spectrophotomer Lab Expands

The ability for HHS students to learn about spectroscopy, the study of visible light dispersed according to its wavelength, has been expanded in Tom Brestel's science classrooms thanks to a follow-up grant to purchase two additional spectrophotometers and the corresponding interface needed to link student computers.

Spectroscopy is a staple of many science vocations. Chemists use spectroscopy to identify compounds and concentrations of compounds in solutions. Physicists use spectroscopy to identify wavelengths of light. Astronomers use spectroscopy to identify the elements in stars. Hospitals use various spectroscopic techniques to test oxygen content of blood and many other medical tests. Spectroscopy is used to help students understand these concepts in Physics, Chemistry, and 11th Grade Applied Science classes, so, most of the student body benefits.

Mr. Brestel has used the Spectrophotometers in a Chemistry Lab involving finding the energies of the photons emitted from different color LEDs to make use of Plank's Constant. The students used the spectrophotometers to find the frequency of each of a red, orange, yellow, green, and blue LED to show that the energy of the emitted

photons was proportional to the frequency. This provides a major step in the understanding of quantum theory needed to explain the electrons in atomic orbitals. The Applied Science students will do a simplified version of this activity in the 3rd quarter and the physics students will do an extended version of the activity in April or May.
